Forms must be submitted before the child may participate in the event. **Forms may be submitted upon check-in at the first day of the event** or mailed to/dropped off beforehand at the church office.

The undersigned represents to **Christ's Chapel Full Gospel Assembly** (herein referred to as CCFGA), a non-profit religious corporation, that he or she is the parent or the legal guardian of the above named child(ren); and, the undersigned does hereby consent to such child(ren) taking part in the CCFGA Vacation Bible School with the full understanding insofar as such activity will involve missions and sporting activity and mingling with other individuals and groups, that there is always risk of injury, illness, loss, and possible consequent expense for medical, diagnostic, and curative treatments, and incidental loss and expense, and the undersigned does for him/herself and for and on behalf of such child(ren) assume the risk of such and expense, and does hereby wholly release WSPC from any responsibility of liability and waives any claims or causes that might arise on account of loss, injury, or expense occasioned by any sort of accident or of her circumstance involving such child(ren), and agrees to hold harmless CCFGA in the event any such claim should arise.

### Waiver of Liability

The undersigned agrees to abide by the rules and regulations, supervision and discipline set and applied by CCFGA and its agents, and does hereby authorize CCFGA or its staff members or other agents, after unsuccessfully exhausting all means of making emergency contact with parent or guardian, to arrange for and consent to x-ray examinations, anesthetic, dental, medical, or surgical diagnosis, and treatment and hold harmless CCFGA from any such occurrence. The undersigned will furnish payment or insurance for any such payment, at his or her own expense.

### Guidelines and Code of Conduct



1. **Family and friends are all invited to join us on Sunday, June 25, 2017 for a closing service from 10:30AM - 12:00NOON** where the children will receive their Certificates of Participation and showcase their work. Please mark your calendars and come support the children. *Children will still need to be signed out on Sunday, June 25, 2017 after the service.*
2. Vacation Bible School (VBS) is an opportunity for children to discover Jesus and grow in their faith and love for Him. **Behavior that is not respectful to other participants or to adult volunteers will not be tolerated.** If any participant exhibits unacceptable behavior while at VBS, the parent/guardian or emergency contact person may be called and asked to pick up the child(ren) from the facility and the child(ren) may be asked not to return for the remainder of the VBS.
3. **VBS will meet July 23-25 from 9:00AM to 12:00 NOON.** Children may be dropped off at the church lobby at 9:00AM and picked up from the church lobby no later than 12:15PM. You must "check" your child in and out. Please do not leave with your child until you have signed them out with an adult volunteer. **This is for your child's safety.**
4. **You must have reliable transportation for your child and your child to and from the church.** The church is not responsible for providing transportation or child care before or after the event. Additional pick-up personnel must be listed on the Release Form located on the back the Permission Slip.
5. Vacation Bible School is staffed by committed volunteers who are giving of their time for the children of the community. For the safety of all participants and volunteers, only prior-approved volunteers are allowed to stay in the VBS classrooms and work directly with the children. *The only exception is with the closing service on Sunday, June 25, 2017 at 10:30AM where family and friends will join together with us to close out the VBS.*
6. We ask that the child(ren) already have had their breakfast prior to coming to VBS. Snacks will be served during VBS but will not substitute for a full meal. Should your child have any dietary restrictions, please make sure that they are indicated on the registration form.
7. VBS will be full of activities, games and a lot of fun! As such, we ask that all electronic devices, toys, hair supplies etc. be left at home. CCFGA is not responsible for items that may be lost or stolen. We ask that the child(ren) NOT bring a cell phone to VBS. They will have access to a phone during VBS should they need to contact you.
8. **We will be having fun outdoors, weather permitting.** Thus, we highly recommend that children wear sunblock before coming to VBS. We also ask that children come in comfortable play clothes and footwear that is suitable for active outdoor play (closed-toe, athletic shoes are most appropriate).
