

ADULT VOLUNTEER CONSENT AND RELEASE OF LIABILITY

Volunteer's Name (the "Volunteer"):

Conejo Valley Church of Christ (the "Organization").

I am an adult volunteer participating in the Vacation Bible School ("VBS") program sponsored by the Organization. I make the following authorizations and releases on my own behalf and of my own free will.

Emergency Medical Authorization. In the event that I become ill, am injured, or am otherwise unable to give consent for myself during my participation in VBS, I authorize the Organization and its duly authorized representatives to consent on my behalf to any X-ray examination, anesthetic, medical or surgical diagnosis or treatment, and hospital care that is deemed advisable by, and rendered under the general or special supervision of, any physician or surgeon licensed to practice in the State or Country in which the care is sought; and likewise to consent to any X-ray examination, anesthetic, dental or surgical diagnosis or treatment rendered by a licensed dentist. This authorization is given in advance of any such treatment being required, solely to provide authority to act in an emergency when I am incapacitated or otherwise unable to provide consent for myself. This authorization is intended solely to facilitate emergency treatment when I am unable to consent for myself; it does not constitute, and does not supersede, an advance health care directive or durable power of attorney for health care, and any such directive or power of attorney that I have executed shall control.

Financial Responsibility. I agree to be financially responsible for, and to fully pay, all costs of any medical or dental care I receive under this authorization. I understand that the Organization does not provide medical insurance for volunteers and that any such treatment is at my own expense and/or that of my own health insurance.

Voluntary Participation and Release of Liability. I understand that my participation as a volunteer is entirely voluntary and that it may involve risks of injury. To the fullest extent permitted by law, on behalf of myself and my heirs, successors, assigns, and personal representatives, I voluntarily release, discharge, waive, and relinquish any and all claims, actions, or causes of action that I may have against the Organization and its officers, employees, and volunteers for any and all personal injury, property damage, or death occurring to me and arising out of my participation in the VBS program — including any such claim based upon the ordinary negligence of the Organization or its officers, employees, or volunteers, and including any claim arising out of the administration of or failure to administer medicine or medication to me. This release does not apply to, and I do not waive, claims arising from the Organization's gross negligence, fraud, willful injury to my person or property, or willful violation of law.

Term. These authorizations shall remain effective from June 15, 2026 through the conclusion of the VBS program, unless revoked by me in writing prior to a specific event and delivered to the Organization. I understand that a signed authorization must be received by the Organization no later than June 16, 2026.

Entire Agreement. No oral representations, statements, or inducements have been made by or between the parties to this Agreement with respect to the subject matter of this Agreement apart from the matters set forth within this Agreement.

Severability. If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect, and the invalid or unenforceable provision shall be enforced to the greatest extent permitted by law.
