TSMYC 2024 Release and Liability Waiver

PARENTAL RELEASE:

I, the undersigned parent or guardian, hereby consent to my child attending and participating in the activities connected with the Tennessee Southern Methodist Youth Camp held at Hillmont Camp in White Bluff, TN during the period from June 10 - 15, 2024. I certify that my child is able to participate in these activities, including sports, swimming, low-ropes course, transportation on camp property, and any other activity that may arise within the confines of the camp program and facilities.

WAIVER OF LIABILITY:

I, the parent or guardian of the above-named individual, acknowledge that participation in athletic and other physical activities associated with the camp program necessarily involves risk of physical injury. I also acknowledge the risk of possible exposure to infectious diseases, including Covid-19, while participating in the camp program. I further acknowledge that Tennessee Southern Methodist Youth Camp is primarily administered by individuals who volunteer their time, rather than paid professionals. In consideration for accepting the registration of the named individual and permitting the voluntary participation of said individual in its activities, I hereby release, discharge, and hold harmless Tennessee Southern Methodist Youth Camp, its employees, volunteers, and other representatives, as well as the Southern Methodist Denomination and it's churches from any and all liability, actions, causes of actions, claims, expenses, and damages on account of injury or illness to my child; even injury or illness resulting in death. I UNDERSTAND AND HEREBY AGREE TO ASSUME ALL OF THE RISKS WHICH MAY BE ENCOUNTERED ON SAID ACTIVITIES. I expressly agree that this release, waiver and indemnity agreement is intended to be broad and inclusive as permitted by the law of the State of Tennessee and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This release contains the entire agreement between the parties hereto, and the terms of this release are contractual and not a mere recital.

The camp is not responsible for personal items that are lost, stolen or damaged. I furthermore accept that disobedience or disregard for the rules of the camp could result in the dismissal of my child from camp. I also understand the camp retains the right to use any photographs, videotapes, motion picture recordings or any other record of this event for promotional publications and materials, the Tennessee Southern Methodist Youth Camp website, or for any legitimate purpose.

EMERGENCY MEDICAL AUTHORIZATION:

I, the undersigned, parent or legal guardian of the participant, a minor, hereby authorize the staff of Tennessee Southern Methodist Youth Camp to act as my Agents, according to their best judgment in any emergency requiring medical attention, to consent to medical, surgical or dental examination and/or treatment. In case of emergency, I hereby authorize treatment and/or care at any hospital. The camper may be transported by camp personnel to medical facilities. I hereby waive and release the camp from any and all liability for any injuries or illnesses incurred while being transported by camp staff for medical attention. All campers must be covered by their own medical insurance. All medical expenses incurred will be the responsibility of the camper or camper's family. I have no knowledge of any physical or mental impairment that would be affected by the named camper's participation in the camp program.

I further state that I HAVE CAREFULLY READ THE FORGOING RELEASE, WAIVER, AND AUTHORIZATION. I UNDERSTAND THE CONTENTS OF THIS ENTIRE DOCUMENT AND I AGREE TO THIS RELEASE AS MY OWN FREE ACT. This is a legally binding agreement, which I have read and understand.
