## **Child Protection Background Checks for Volunteers Information Sheet**

In December of 2014, Pennsylvania's Child Protective Services Law was enacted to strengthen child protection in the state. It's gone through a number of revisions since then, but it now says <u>volunteers</u> who are age 18 or older are required to obtain clearances if they provide "care, supervision, guidance or control" of children <u>and</u> have regular and repeated contact with them as an integral part of their responsibilities. This now means that all Summit Church volunteers, who have direct contact with children, must have these clearances. This would include but is not limited to those who serve in the nursery, Sunday School, VBS, youth group and at HIS Kids, etc. <u>Employees</u> are also required to obtain clearances.

Adult volunteers (18 +) who have lived in PA consistently for the past 10 years will need to obtain:

- Pennsylvania State Police Criminal History Check
- Pennsylvania Child Abuse History Clearance

If you have <u>NOT</u> lived in PA consistently for the past 10 years you will also need to obtain:

• FBI Criminal History Check

\*If you have new clearances from another volunteer or employee position, those may be used; we just need copies. FYI – clearances obtained for volunteer purposes cannot be used for employment.

Clearances are easily applied for online and <u>there is no cost for volunteers unless a federal criminal</u> **history check is needed**. We can help you with the application process!

Once you have obtained your clearances, bring them to us and we will make copies; clearances are good for 5 years.

It is our hope that this "extra" step in the volunteer process will in no way keep you from serving in the children's ministries of Summit Church. Our children need you and we do this for them!

## Instructions for Federal Criminal History Check - Fingerprinting

- Go online to <u>www.identogo.com</u> to register –
- Search for Services by State: enter Pennsylvania and click "Go"
- Scroll down to Enrollment Services and select Digital Fingerprinting
- Enter this service code: 1KG6ZJ click "Go"
- Page will read: 1KG6ZJ Pennsylvania DHS Volunteer (This is the service code for a Dept of Human Services Volunteer their process is easier that the Dept of Education and is good for church volunteers.)
- Follow the prompts from there to set up an appointment for fingerprinting. You will pay (one place said \$23.00) when you go for your appointment. You will be sent a letter with the results of the review on DHS letterhead. Please bring that letter in to us and we will make a copy of it for our records.
