- 1) Please make sure your child has a good night's sleep and a substantial breakfast each day before participating. We will provide plenty of water and a good snack each day as well.
- 2) Please apply plenty of sunscreen to your child and have your child wear appropriate clothing. Suitable clothing includes VBS T-shirt, shorts or comfortable pants (may get wet/dirty), closed-toed shoes (no sandals or flip-flops). If your child is prone to bug bites, you may want to apply bug repellent before arriving at VBS. We are not authorized to apply bug repellent or sunscreen.
- 3) Please arrive on time for drop-off and pick-up times. When you bring your child to VBS, you must make sure your child is taken to their group and signed in with their Group Leader in Opening Assembly (in auditorium). At pick-up time (in auditorium) please remember your child will not be released to you without your SIGNATURE or INITIALS on the Attendance Sheet held by your child's Group Leader.
- 4) Our goal and desire is for every VBS participant to have the safest experience while being involved in Roar VBS 2019. No parent/guardian, family member, or friend may stay in VBS activity areas or interact/observe the VBS activities unless participating as an approved VBS Volunteer.
- 5) Please keep in mind that failure to turn in your paperwork by the due date of JULY 21<sup>st</sup> will cause your child's spot to be given to someone else, even if their name is on the sign-up list. To avoid an uncomfortable and disappointing situation, please talk to the VBS Directors before bringing your child's friend(s) on any VBS day (if they have not previously registered).
